The texts made available in this form represent part of the contributions to the conference on “Transnational Capital and Transformation of the Elites”, held at Université de Paris I Panthéon-Sorbonne on June 4-5, 2014. They all have the character of work-in-progress and cannot in any way be considered as finalized articles. In some cases, the authors have indicated that they do not wish their texts to be quoted. The entire conference programme can be found at the end of this introductory text.

The current processes of globalisation in many senses weaken, or even dissolve national borders. Obvious examples are the global financial markets, where assets can be transferred in micro seconds from a bank in one country to a bank in another country, or the introduction of a common currency such as the Euro which melt European economies together. While larger companies organize production as a global enterprise, offering job careers that transcend national borders, consumption markets also become increasingly global, affecting culture, languages and life-styles. Migration in varying forms, from tourism to migrant labour, contributes to making those life-trajectories uncommon that are entirely limited to one country. In education, supranational bodies such as the World Bank, the EU or the OECD, have become powerful actors in the reshaping of national educational systems according to new organisational models. The Bologna process is a paradigmatic example with its ambition to make Europe a common space for higher education and facilitate migration of students, teachers and researchers over national borders by streamlining the national systems of higher education.

With the growth of new transnational social spaces created by the de- and reconstruction of national borders, the importance of transnational or global forms of symbolic assets seems to increase. Symbolic capital of this kind include for example internationally oriented educational diplomas such as International Baccalaureate or Masters in Business Administration, language skills, especially in English, knowledge of the institutional and organizational landscape that connect countries, and familiarity with globally shared cultural forms.

Still, the nation states play a crucial role in creating the positions from where access to transnational resources is gained; individuals, social groups and institutions who are strong holders of nationally recognized forms of symbolic capital outlive others in the competition for transnational capital. Moreover, the conversion of capital can work in both directions: while resources built up nationally are often a prerequisite for accumulating assets recognized on transnational symbolic markets, assets accrued on transnational markets may be used in the competition for

nationally defined social positions. The analysis of these kinds of conversions needs to take into account differences between social fields with different forms of recognition, i.e. the kind of symbolic capital at stake. Thus, while transnational symbolic capital may have common components, such as English language proficiency and general knowledge of the state of the world, it also takes different forms adapted to the beliefs on which particular social fields are founded. It is not the same in, for example, the literary field, the field of social sciences, the field of international banking or the emerging field of transnational political and administrative bodies. Assets that transcend national borders are not historically new. Much to the contrary, elites – for example the aristocracy or the *grande bourgeoisie* that succeeded it – have traditionally upheld considerable international assets as part of the privileged resources on which their positions have been founded.

The aim of the conference is to investigate the production, accumulation and circulation of transnational capital connected to social groups, institutions and social fields, such as the economic field, educational fields or fields of cultural production. Focus is on the relation between, on the one hand, structures and practices connected to transnational forms of capital, and, on the other hand, nationally situated systems and practices producing similar assets but bound to the nation state. Globalization and internationalization processes are analysed as both stakes and outcomes of strategies taking place in both transnational and national social spaces. Particular attention is given to how such stakes and strategies unfold in historical contexts. Rooted in traditions in social and human sciences, primarily in the disciplines of sociology and history, the conference will especially focused on research in certain target areas that correspond to on-going research among its members. These are: Upper Secondary and Higher Education, Transnational Strategies of Social Groups, especially among Elites, Travelling Mobility and the Accumulation of Transnational Symbolic Assets.
